Course description

The main aim of this course is to cover several central topics in metaphysics. In chronological order, we'll introduce you into the mysteries of *causation* (how is it different from mere correlation?), *freedom and determinism* (do we have free will?), *laws of nature and necessity* (are all regularities around us just coincidences?), *personal identity* (what makes you, you?), *mental states* (the mind-body problem), as well as the riddles of *(non-)existence* (are there things that don't exist?). The course doesn't presuppose extensive philosophical knowledge, but familiarity with the basic vocabulary of analytic philosophy is helpful.

Evaluation

- Two written assignments to be submitted electronically (in INSPERA) before deadlines set by the department.
- The first assignment is between 1500 and 2000 words (excluding table of contents, list of references, etc.) = 30 % of the final grade. Unsupervised.
- The second assignment is between 2500 and 3000 words (excluding table of contents, list of references, etc.) = 70 %. Supervised. One *must* attend the supervision to be allowed to submit the second paper.
- MA students: same as above + 1000 words more each essay.
- Each student chooses her or his own topic from a list of preassigned themes. The topic has to be approved by the professor in advance
- Both assignments can be written in English or Norwegian.
